## Contract

on condensed in-service training for experienced psychotherapists in Essential  
Psychotherapy EPT XII

between

the graduate psychologist Wolfgang Erhardt, Eichkuhle 22, 53773 Hennef as director and  
owner of the Institute for Essential Psychotherapy

and

the following

Contract for the Compressed Advanced Training in Essential Psychotherapy

is closed



1. The Institute for Essential Psychotherapy, represented by its director Wolfgang Erhardt, will offer a condensed advanced training in Essential Psychotherapy (EPT XII for short) in Denmark from November 2020.
2. The training consists of the following events: 6 Modules of 6 days each in Aarhus. In total there are 36 days of seminar with a minimum of 6 hours of instruction each. Those are **216 hours** and this corresponds to **288 units of training** of 45 minutes each as one teaching unit.
3. The events are conducted and supervised by the announced lecturers and supervisors and in case of prevention by other lecturers and supervisors authorized by the Institute for Essential Psychotherapy. The institute, represented by the owner, the graduate psychologist Wolfgang Erhardt, is not liable for any costs incurred in case of unforeseen cancellation of the event (with the exception of the pro rata seminar fee).
4. The participants commit themselves to attend the training courses on the scheduled dates. Exceptions require the confirmation of the institute or seminar management. Even if individual events are not attended by the participants, the agreed seminar fee must be paid. If, for reasons of illness, it is not possible for the participant to attend a seminar, it is possible to make up for this seminar in another training cycle. Since the seminar fee has already been paid, it does not have to be paid again at the "catch-up seminar".
5. The training contract can only be terminated prematurely by the participants for an important reason, e.g. prolonged illness which results in an occupational disability. The termination must be in writing. In the event of termination for an important reason, the seminar fees due until receipt of the notice of termination must be paid. No seminar fees that have become due and have been paid by then will be refunded. The obligation to pay the remaining seminar fees shall not apply.
6. Participants may be excluded by the training manager from further participation in the training if they either endanger themselves or block the process of the training



due to personal difficulties. The exclusion procedure can only be initiated after agreement between the seminar leaders and supervisors. With the exclusion the contractual relationship is dissolved. The seminar fees due until the exclusion are to be paid by the participant. No seminar fees that have become due and have been paid by then will be refunded. The obligation to pay the remaining seminar fees does not apply.

In the event of a cancellation of the contract before the beginning of the 1st training module, i.e. a cancellation, seminar fees already paid, deducting the registration fee, will be refunded.

7. At the end of the training, the Institute for Essential Psychotherapy, represented by its director Wolfgang Erhardt, will issue a certificate of completion of the condensed further training in essential psychotherapy.
8. Upon application, participants can receive an extended final certificate with the title "Therapist for Essential Psychotherapy" if the following requirements are met:  
Participation in all modules of the seminar  
Participation in at least 10 individual sessions in EPT or in at least 5 guided group supervisions (3 hours)  
Preparation of the project  
Passing the oral examination
9. If the participants have not attended some of the events for an important reason, the certificate of completion can still be issued by the head of the training course if the required professional qualification is available.
10. If required, participants can receive further training points from the Psychotherapeutic Association NRW for participation in the seminars and group supervision.
11. The following **fees** are agreed for the the training EPT XII:

Upon conclusion of the contract, a **deposit of € 268,-** is due, which will be deducted from the payment of the first module of the seminar or the total amount.

For the 6-day-long modules of the seminar **€ 682,-** per seminar are to be paid.

The seminar fees are to be paid **4 weeks** before the respective seminar to the account **of the Institute for Essential Psychotherapy / Ltg. W.Erhardt**
